Attached you will find the 2023 forms for the Presbytery of Northern Waters camping scholarships. If you wish to apply for funds for your upcoming summer camping trips, please complete the form and return it to the Presbytery Office.

Scholarships are available for all ages. **Please return the attached form to the Presbytery office by May 31, 2023.**

When funds are granted, they are given exclusively for that event and for the number of individuals that you list on your application. The Presbytery expects that monies granted will be used only for that event and for those individuals. If this is NOT the case, you are expected to return the funds to the Presbytery. ***A form will be included with the grant approval for you to report this information and return to the Presbytery Office after campers have attended their event or no later than October 1, 2023.**

Please encourage campers to register as soon as possible as this will help determine whether camps will be able to continue with this year's camp programs.

Again, this year, Clearwater Forest has instituted a voluntary three-tier fee program. You may choose the tier that is most suitable for your situation. It is really a free will system; you tell us that is affordable for you or your family. All participants receive the same Clearwater Forest experience no matter what they pay! For those who cannot afford Tier I, **additional financial assistance is available to ensure that all children, youth and adults have the wonderful opportunity to attend camp.** In addition, some families might use this system to give themselves a multi-child or multi-week discount.

- Tier I is our historically subsidized rate and does not reflect the true cost of operating summer camp programs.
- Tier II is our partially subsidized fee for those who can pay a little more but still cannot afford the actual cost of camp.
- Tier III more closely accounts for the true costs of camp, including wear and tear of facilities and grounds.
